



Arizona Charitable Tax Credit

Put your Arizona tax dollars to work for Ryan House!

Under the Arizona Charitable Tax Credit (also known as the Working Poor Tax Credit), you can give up to \$800 if married and filing jointly and up to \$400 as an individual. You get the entire amount back as a 100 percent state tax credit. This is available in addition to the public and private school tax credits. You do not have to itemize deductions to claim this credit on your state tax return.
